RELEASE OF LIABILITY

NOTICE: This is a legally binding contract. In order to be permitted by Campbell Anderson Holdings LLC, Petra Cliffs Climbing Center, and Petra Cliffs Mountaineering School to climb at Petra Cliffs Climbing Center *and/or* participate in any programs offered by Campbell Anderson Holdings LLC, I agree to the following release of liability, and I make the following representations:

I hereby acknowledge the inherent extreme risks in rock climbing, including but not limited to: falls from or contact with walls and equipment, poor decision-making, inattention of belayers, actions of other climbers, misuse or failure of equipment, climbing holds which may have become loose or damaged, twisting an ankle, breaking a bone, or other physical injury, and accidents which cannot be foreseen. **I voluntarily assume all such risks with full knowledge and appreciation of the danger and risk involved.**

I hereby assume the risk of any injury that may occur while using Petra Cliffs Climbing Center and/or participating in any Campbell Anderson Holdings LLC programs. Whether these risks arise from my negligence, the negligence of others, or through a non-negligent accident, I release and discharge Campbell Anderson Holdings LLC, its employees, agents, officers, contractors, heirs, and assigns from liability resulting from any such injuries while using Petra Cliffs Climbing Center and/or participating Campbell Anderson Holdings LLC programs. Further, I freely and voluntarily waive all rights to bring legal action against Campbell Anderson Holdings LLC, its employees, agents, officers, contractors, heirs, and assigns arising from my use or presence at the Petra Cliffs Climbing Center and/or participating in Campbell Anderson Holdings LLC programs.

I agree to pay attention to the conditions of any ropes, anchors, and/or other climbing equipment I may be using, and promptly report to staff members any damage I notice or cause. I certify that I have read the posted rules, and I agree to abide by these rules and any future rules, and if staff makes a specific request to me, I agree to comply. I understand that indoor climbing is not the same as outdoor climbing, which requires additional skills, and I agree to seek qualified instruction before attempting to climb outside.

I am at least 18 years of age and otherwise legally competent to sign this agreement. I am in good physical condition and that there are no limitations that will affect my ability to safely use Petra Cliffs Climbing Center and/or participate in any Campbell Anderson Holdings LLC programs.

- NO SITTING WHILE BELAYING.
- CHILDREN UNDER 12 MUST HAVE SUPERVISION AT ALL TIMES.
- NO RUNNING IN THE GYM.
- PROPER LANGUAGE MUST BE USED AT ALL TIMES.
- FOOD/DRINK MUST BE KEPT OFF THE MATS.
- CLIMBERS MUST BE LOWERED AT APPROPRIATE SPEED.
- NO SWINGING ON ROPES.
- NO BOULDERING, CLIMBING OR STANDING UNDER OTHER CLIMBERS.
- NO BOULDERING ABOVE HEAD HEIGHT.
- CLIP INTO HARNESS, NOT DIRECTLY INTO DAISY CHAIN.
- NO PETS.
- NO ALCOHOL OR DRUGS ON PREMISES.
- NO LOOSE CHALK. CHALK BALLS ONLY.
- INSTRUCTION IN GYM BY PETRA CLIFFS STAFF ONLY.
- YOU MUST BE 18 YEARS OLD OR OLDER TO USE THE FITNESS EQUIPMENT.
